

How will Andorra become a green country?

Andorra will go from producing energy using coal, to generating clean energy with an installed capacity of 1,843.6 MW as a result of 7 hybridised renewable projects, 2 storage projects with batteries, a green hydrogen project and a synchronous compensator.

Does Andorra have a sovereign wealth fund?

Andorra adopted the Euro in 2002 and in 2011 signed a Monetary Agreement with the EU making the Euro the official currency. Since 2013, Andorra has the authority to mint Euro coins. There are no limits or restrictions on remittances provided that they correspond to a company's official earning records. Andorra has no Sovereign Wealth Fund (SWF). 7.

What are the 10 energy communities in Andorra?

This is another step towards the digitalisation of the area surrounding Andorra together with the development of 10 energy communities. These are Andorra, Híjar, Albalate del Arzobispo, Puebla de Híjar, Jatiel, Castelnou, Ejulve, Molinos, Alacón and Alcorisa.

Does Andorra have a state monopoly?

Andorra has 35 state-owned enterprises (SOEs) associated with health, social services, and energy and telecommunication, which are generally allowed to compete with private enterprises without restriction. The only exception is the government-owned Andorra Telecom, which has enjoyed a monopoly on the telecommunications industry since 2015.

What are the mitigation actions in Andorra?

The mitigation actions are implemented across all sectors, with the energy sector being the major focus, particularly in the areas of buildings, mobility and electricity. Andorra's historical GHG emissions data show that the emissions level reached its peak around 2005 and have been stabilized since then.

Spanish and Portuguese utility Endesa, part of Enel, has provisionally won 953MW of connection rights to build renewable energy resources and battery storage in the Spanish city of Andorra, possibly rising to 1,200MW.
