What is the Ministry of energy of the Republic of Lithuania?

The Ministry of Energy of the Republic of Lithuania (Lithuania: Lietuvos Respublikos energetikos ministerija) is a government department of the Republic of Lithuania. Its operations are authorized by the Constitution of the Republic of Lithuania, decrees issued by the President and Prime Minister, and laws passed by the Seimas (Parliament).

How has Lithuania reformed its energy sector?

In 2009,the EU adopted the Third Energy Package,a package of legislative measures aimed at liberalising EU energy markets. Based on the ownership unbundling requirements of the Third Energy Package,Lithuania has reformed its electricity sector by separating transmission from generation and supply activities.

Why is Lithuania investing in alternative energy import routes?

This is because ever since the reestablishment of its independence, Lithuania has been investing in alternative energy import routes. These included the development of the Butinge oil terminal, the electricity interconnections NordBalt and LitPol Link, the Klaipeda LNG terminal and the Gas Interconnection Poland-Lithuania.

Does Lithuania import electricity?

Since then, the shares of electricity imports, natural gas and bioenergy have increased. Today, Lithuania imports over 70% of its electricity needs, while bioenergy is taking the lead in domestic energy supply.

Does Lithuania have a good gas market?

However,Lithuania maintains high market concentrationin the residential gas market with regulated prices. The implementation of the NECP requires around EUR 14 billion of public and private financing in the clean energy transition. In 2021,EU and national recovery funds will be disbursed under the National Resilience and Recovery Plan.

Which power plant provides energy storage in Lithuania?

Kruonis Pumped Storage Plantprovides energy storage, averaging electrical demand throughout the day. The pumped storage plant has a capacity of 900 MW (4 units, 225 MW each). Kaunas Hydroelectric Power Plant has 100 MW of capacity and supplies about 3% of the electrical demand in Lithuania.
