What if Afghanistan's environmental policies are inconsistent with the World Bank ESF?

Where national laws and policies are inconsistent with the World Bank ESF or UNICEF Environmental and Social Standards, UNICEF will look to achieve or implement whichever standards are more stringent. Afghanistan is party to a member of international environmental agreements, the most important of which are shown in Table 3.

Why is ess8 important in Afghanistan?

Afghanistan, where HER will be implemented, is prone to climate induced natural disasters such droughts, floods and harsh winters. ESS8 deals with integrating climate resilience considerations in projects. Mitigating vulnerability of communities to climate change impacts or disaster risks and reducing GHG emissions.

Are UNICEF's environmental and social standards aligned with the World Bank ESF?
