What is Romania's energy strategy?

This combination of views was also taken into account in Romania's energy strategy document according to which "the growth and increase in the competitiveness of the Romanian economy, the increase in the quality of life and the concern for the environment are indissociably linked to the development and modernisation of the energy system".

How much does Romania contribute to EU emissions?

Romania is currently contributing with approximately 2.5 % of the total share of GHG emissions at EU level, excluding LULUCF, which is falling compared to 1990, when contribution was over 4 %58. The largest share in these emissions is accounted for by emissions from the energy sector.

How much investment does Romania need to achieve the energy strategy?

Investment needs to achieve the objectives of the Romanian Energy Strategy are estimated as EUR 127 billionoverall from 2021 to 2030 (annually around 6% of current GDP), mostly in energy demand sectors. The use of Union level funding sources such as cohesion policy or the Modernisation Fund is not yet specified.

How did the ETS directive help modernise the energy sector?

However, to help modernise their energy sectors, ten new Member States were given the option under Article 10c of the ETS Directive to exempt themselves from the 'full auctioning' rule and to continue allocating a limited number of emission allowances to power plants for free until 2019. Why was the derogation allowed?

What is the EU ETS directive?

This directive has underpinned the reformation of the EU emissions trading scheme,has led to the setting of national targets for emissions not regulated by EU ETS and of national targets for renewable energy,to the establishment of a legal framework for the sequestration and storage of carbon dioxide and to the Energy Efficiency Directive.

When will Free Electricity Allocation be available in the EU ETS?

This provision was introduced for phase 3 of the EU ETS (2013-2020), when auctioning became the default method of allocating allowances for electricity generation. In the context of the 2030 climate and energy framework, EU leaders decided that this free allocation should also be available during phase 4 of the EU ETS (2021-2030).

On 21 September 2020, the Commission adopted revised ETS State Aid Guidelines in the context of the system for greenhouse gas emission allowance trading post-2021, as part of the modernisation of all carbon leakage prevention tools related to the EU ETS, such as free allocation of CO2 emission allowances.
