

## Have photovoltaic panel manufacturers gone bankrupt recently

What happened to SunPower branded solar panels?

From pv magazine USA Residential US solar company SunPower Corp. (Nasdaq: SPWR) has filed for bankruptcy. Nevertheless,the situation doesn't affect the SunPower branded solar panels designed,manufactured,and sold by Maxeon Solar Technologies in Europe and elsewhere outside of the US and Canada.

How did SunPower's bankruptcy affect the solar industry?

Even before the bankruptcy filing, SunPower ceased solar lease and PPA offerings, creating problems that reverberated through the industry. The effects trickled down to dealers and installers like Renova Energy, a major SunPower partner that services the Nevada and California markets and maintains an excellent 4.9-star rating on SolarReviews.

Will European Solar supply chain companies go bankrupt?

Solar is central to the EU's hopes to generate 45 per cent of its electricity from renewable sources by 2030. Since August, however, eight European solar supply chain companies have either filed for bankruptcy, paused production, warned of factory closures or restructured debts, according to SolarPower Europe.

Is SunPower a bankrupt company?

The US residential solar installer has filed for bankruptcy, among the largest in a series of major bankruptcies in the industry. From pv magazine USA Residential US solar company SunPower Corp. (Nasdaq: SPWR) has filed for bankruptcy.

Will SunPower bankruptcy affect my warranty?
