What is the Heard Island & McDonald Islands Marine Reserve management plan?

This management plan may be cited as the Heard Island and McDonald Islands Marine Reserve Management Plan. This management plan will enter operation following approval by the Minister under s.370 of the EPBC Act on the day after it is registered under the Legislative Instruments Act 2003 or on a later date specified in the Minister's approval.

What is Heard Island & McDonald Islands Marine Reserve?

Heard Island and McDonald Islands Marine Reserve means the areas declared as a Commonwealth reserveby that name under the EPBC Act on 16 October 2002 and amended on 28 March 2014. HIMI means Heard Island and McDonald Islands. means the part of the Australian Government agency with responsibility for administration of the HIMI Territory.

When was the Heard Island and McDonald Islands reserve proclaimed?

The Reserve was proclaimed under the EPBC Act as the Heard Island and McDonald Islands Reserve on 3 October 2002. (s.514A) and a Commonwealth authority for the purposes of the Commonwealth Authorities and Companies Act 1997.

Why are Heard Island and McDonald Islands isolated?

However, the site's isolation assists in reducing anthropogenic impacts upon the site's values. Heard Island and McDonald Islands are located in the Southern Ocean, approximately 1,700 km from the Antarctic continent and 4,100 km south-west of Perth.

Who manages Heard Island & McDonald Islands?

Do we need sanctuary protection at Heard & McDonald Islands?
