Will allkem & Livent merge?

REUTERS/Brendan McDermid/File Photo Purchase Licensing Rights SYDNEY,Dec 19 (Reuters) - Investors in Australian lithium producer Allkem (AKE.AX) voted on Tuesday to accept a \$10.6 billion merger offer from U.S. giant Livent (LTHM.N) that would create one of the world's biggest lithium companies.

How many shares will Livent shareholders get?

Livent shareholders will get 2.406 shares in the new firm for each existing share. Graves will be CEO of the new company, while Allkem's Peter Coleman will be its chairman. The company, which has yet to be named, will be listed on the NYSE and headquartered somewhere in the United States.

How is the market capitalization of allkem & Livent calculated?
