

Will Northvolt AB buy Novo energy?

However, fast forward two years and Volvo has released a statement saying that it has notified Northvolt that it will "invoke its redemption rights to acquire Northvolt's shares in Novo Energy". "This action follows a breach of the parties' shareholders' agreement where Northvolt AB has not fulfilled its financing obligations," the statement said.

Will Volvo take full ownership of Novo energy?

In a surprise move, the carmaker on Wednesday announced plans to invoke its redemption rights to take full ownership of the NOVO Energy project as Northvolt has failed to fulfill its financing obligations. "This action follows a breach of the parties' shareholders' agreement," Gothenburg-based Volvo said in a statement.

Will Volvo keep Novo energy as a battery factory?

Volvo stressed that it had a "diversified and resilient battery supply chain" and that its electric car rollout would not be affected. Experts said that should Volvo want to keep Novo Energy as a battery factory, only Asian manufacturers such as China's CATL, Japan's Panasonic or South Korea's LG were currently able to make cells.

Why did Northvolt stop donating more capital to Novo energy?

Northvolt, which is fighting to raise a rescue package in the coming days, said it had decided not to contribute more capital to Novo Energy and instead focus its funding on its sole current factory in Skellefteå in northern Sweden, where it has struggled to ramp up production.
