

How many SMEs are there in Papua New Guinea?

That will involve dealing with some key constraints. There are 49,900 formal small and medium-sized enterprises in Papua New Guinea, 90 per cent of which are male-owned. According to Maken, SMEs contribute 6 per cent to Gross Domestic Product (GDP). They are mostly concentrated in: wholesale, retail, agriculture, tourism and fisheries.
