Did a company defraud solar panel owners?

A company which defrauded solar panel owners by selling them goods and services they did not need has been ordered to pay back its victims hundreds of thousands of pounds.

Can I claim compensation for mis-sold solar panels?

If you feel you were mis-sold solar panels for your home you could claim compensation. Back in 2019, it was reported that the Financial Ombudsman Service had around 2000 complaints from unhappy customers who felt they had been mis-sold their solar panels, with more coming in every week.

Are solar panels a scam?

This isn't so much the sign of a scam as it is a word of caution and advice: solar installers should give you a lot of information when providing a quote, including things like model numbers of the solar panels they plan to use. For example, some quotes we've seen just say things like "Qcells panels" or "REC panels".

Customer complaints against the country's residential rooftop solar industry have increased dramatically in recent years. One-star ratings on Solar Reviews increased more than 1,000% since 2018.
