

# Solar power generation exemption project

Will new renewables projects be exempt from electricity generator Levy?

New renewables projects will be exemptfrom the Electricity Generator Levy under new plans from the UK Government. Publishing the Autumn Budget today, the Treasury said it will legislate to ensure new renewables projects will be exempted if their sanction decisions are made on or after November 22,2023.

#### What is the new investment exemption?

12. The new investment exemption introduced by this clause was announced at the Autumn Statement 2023. The electricity generator levy is a 45% charge on exceptional amount of generation receipts on incorporated businesses that generate electricity in the UK. It is in effect until 31 March 2028.

## What is a generating station exemption?

Where the exemption applies, the effect is to treat any capacity resulting from a project as not being generation of a relevant generating station, as defined in section 280 (1) Finance (No, 2) Act 2023. 4. For a new generating station, the exemption will apply to the whole of the generation receipts from that station.

## What is a generation exemption?

The exemption will apply to generation receipts that can be attributed to new or additional generation capacity, or where substantially all of the plant in an existing station is replaced.

#### Can solar projects be promoted under the NPS?

This has meant that, while utility scale solar projects have been able to be promoted under the NPS for energy infrastructure, developers have had to follow a more protracted route to gaining planning permission: developers have had to rely on the general policy support within EN-1 for their solar projects.

#### What is the electricity generator Levy (EGL)?

Introduced during last years' Autumn Budget, the Electricity Generator Levy (EGL) imposed a temporary 45% tax rate on "extraordinary profits" of renewables firms enjoying higher power prices. The move has been slammed by the sector as a "penalty" on renewables pioneers, and comes as the sector now faces wide-ranging challenges around inflation.

The Union Budget for 2023-24 had provided for an allocation of Rs 7,327 crore for the solar power sector including grid, offgrid, and PM-KUSUM projects. This was a 48 per cent increase over the previous Rs 4,979 crore provided in the ...
