EU Delegation to Tajikistan Tajikistan, a landlocked and predominantly mountainous nation, is home to a youthful and largely rural population of 10 million. The country's terrain is 93% mountainous, with 34% of its land dedicated to agriculture. It harbors 60% of Central Asia's hydro-resources.
