Do I have to pay income tax if I generate electricity?

Where the generation tariff is received by an individual, other than in a business capacity, and it is not chargeable as miscellaneous income, no Income Tax liability will arise. This will usually be the case where an individual generates electricity mainly for use in their own home.

Who is taxable if a business installs solar panels?

The businessinstalling the solar panels is the taxable person (if they are, or should be registered for VAT) and they are supplying the owners of the site with a 'cheap' supply of electricity in the course of the furtherance of their business.

Are solar panels tax-free in the UK?

The supply and installation of "energy saving materials",including solar panels,is currently subject to a reduced VAT rate of 5% in the UK. The European Commission is currently challenging this policy,arguing that the tax incentive goes beyond the scope of the law.

Are solar panels a special rate expenditure?

With effect from 1 April 2012 for corporation tax and 6 April 2012 for income tax, all capital expenditure on the provision of solar panels is specifically designated as special rate. The reason for designating solar panel expenditure as special rate expenditure was to ensure clarity of treatment.

Do solar panels save tax?

Your tax saving by investing in solar is £22,800.00! As a rough rule of thumb,the tax saving is roughly equivalent to 1 year of benefits of your solar array.
