

## The two sessions released energy storage and new energy policies

What is the 'guidance on accelerating the development of new energy storage?

Since April 21,2021,the National Development and Reform Commission and the National Energy Administration have issued the 'Guidance on Accelerating the Development of New Energy Storage (Draft for Solicitation of Comments)' (referred to as the 'Guidance'), which has given rise to the energy storage industry and even the energy industry.

What is the 'guidance' for the energy storage industry?

Based on the above analysis, as the first comprehensive policy document for the energy storage industry during the '14th Five-Year Plan' period, the 'Guidance' provided reassurance for the development of the industry.

Why did the energy industry release the 'guidance'?

The industry has given a high degree of recognition to the release of the Guidance and positive feedback. On July 23, the National Development and Reform Commission and the National Energy Administration formally issued the "Guidance" after fully soliciting suggestions from all walks of life.

What is a two sessions report?

The report is the central part of China's "Two Sessions" meetings. Delivered by the premier, it outlines government achievements from the past year and sets goals and directions for the coming year. It is also usually when the country's GDP growth target for the year is announced. What are the Two Sessions?

How many provinces and cities in China are implementing energy storage policies?

At present,more than 20 provinces and cities in China have issued policies for the deployment of new energy storage. After energy storage is configured,how to dispatch and operate energy storage,how to participate in the market, and how to channel costs have become the primary issues which plague new energy companies and investors.

Will energy storage eliminate industrial development?

In the context of the 'dual-carbon' goal and energy transition, the energy storage industry's leapfrog development is the general trend and demand. The follow-up actions will inevitably introduce a series of policies for the development of energy storage to eliminate industrial development. Faced with 'obstacles' one by one.
