How can I get paid for solar panels?

Additionally, Good Energy launched a new scheme in October 2024, which helps you get paid for the certificates (REGOs) produced when your solar panels generate electricity. Energy suppliers buy them to show that the electricity they sell is renewable.

### Does fit pay for solar panels?

The FIT scheme still pays many solar panel ownersfor the electricity they generate at home, but it is closed to new applicants. All large energy suppliers - with more than 150,000 domestic electricity customers - must participate in the SEG. Smaller suppliers can choose to offer solar export tariffs too.

### How can solar panels make money?

The Smart Export Guarantee (SEG) scheme can also help solar panel owners earn money by exporting excess energy back to the grid. Solar panel subsidies have been an important tool to encourage homeowners and enterprises to adopt renewable energy.

### Can I get solar panels installed in my home?

There's help available get solar panels installed in your home, but you usually need to be on certain benefits or have a low income to be eligible. What each scheme offers, and its eligibility criteria varies: The Energy Company Obligation (ECO) scheme.

#### Will new solar homes get a payment from suppliers?

New solar homes and businesses creating and exporting electricity to the grid will be guaranteed a payment from suppliersunder new laws to be introduced by the government this week (Monday 10 June).

#### Do you pay VAT on solar panels?

Homeowners will pay 0% VATon solar panels and other energy-saving materials until April 2027, compared to 5-20% previously. Though there are a few exceptions. For example, you will need to use the same provider to supply and install solar panels to qualify for 0% VAT.
