How do solar panels attach to a roof?

Installers fix solar panels to a roof by lifting up some roof tiles and attaching mounting bracketsto the rafters, before carefully placing the tiles back where they were. They'll then attach rails to these brackets, before locking solar panels into the rails.

Can I use solar roof tiles instead of solar panels?

What you need to do is speak to your local council and let them know about your decision to install. Unless there is a valid reason to state otherwise, permission for the installation should be granted. In some conservation areas(such as historical ones), it may be requested that you use solar roof tiles instead of panels.
